RULES

- All artwork must be original in design and executed by the applicant. Each artist may display and sell only in the category in which their work has been juried and accepted. **No commercial dealers, agents, kits, crafts, or castings from commercial models. No buy-sell.**
- Artist must exhibit and be present during the complete show from 9:30 AM – 5:00 PM on Saturday and from 9:30 AM – 5:00 PM on Sunday. The Festival will be open for music and food until 8:00PM Saturday evening. Artist may remain open if they desire. Security personnel will be present throughout the weekend if you decide to close at 5:00PM. If the work is produced by more than one artist, all artists are to be present. Artists showing separately produced work under one name will not be allowed to participate. Spouses or other representatives are not allowed to replace the artist.
- The work of one exhibitor may be displayed in each assigned space. A team producing a single product such as jewelry, ceramics, etc., may qualify as a single exhibitor, however, teams may consist of not more than two persons and both names must be on the application.
- Artwork reproduced from the works of the masters, from advertisements, or from widely circulated photographs are not considered original works of art and will not be accepted or allowed to be displayed or sold.
- Jewelry: Only artists accepted in the jewelry category may display and sell jewelry. Jewelers must be the designers and hands-on makers of their work. **Assembled prefabricated jewelry is not permitted.**
- Prints: Only prints produced by the artist executed by monoprint, lithograph, serigraph and similar, properly signed and numbered, are permitted.
- All paintings should be appropriately framed or mounted. Unframed watercolors, drawings, and graphics must be displayed in a portfolio or bin.
- Nudity in the form of art is acceptable; however, overtly explicit or offensive works which may be incompatible with accepted community standards are prohibited.
- Assigned spaces may not be reassigned, conveyed, or transformed in any manner by the artist.
- Animals, bicycles, roller blades, skateboards, or skates are not permitted within the confines of the festival.
- Parking and traffic will not be permitted inside the exhibit area (interior booths) after 9:00 AM on the 15th or 16th.
- Displaying ribbons or awards from other shows is not allowed.
- Upon acceptance by AWT's Jury Committee, the booth fee is non-refundable unless the artist should choose not to exhibit. Requests for refunds must be in writing and postmarked on or before October 1, 2011. AWT will not refund booth fees due to inclement weather, acts of God, extenuating circumstance, etc. Checks cannot be postdated. **The \$10 jury fee is in addition to the booth fee and is non-refundable.**
- Applications will be juried and notice will be mailed to all who apply. If you wish the same space you were assigned in previous years, or space next to a friend, please submit your application early. All requests will be granted at the discretion of the AWT Committee and only as space permits.
- Artists violating the rules of the festival will not be permitted to exhibit and will become ineligible for prizes and awards and admission to future AWT events. AWT reserves the right to enforce any of the rules as stated.

CURATORS CHOICE DRAWING
